

## DECLARATION OF CONSENT AND DISCLAIMER

for the supervised Stöckli Performance Ski Test

from **SPORT B. RIML GmbH** in cooperation with **SPORTHÜTTE FIEGL** and the ski brand **STÖCKLI**

### GENERAL TERMS AND CONDITIONS OF BUSINESS

The participant confirms with their signature that the personal data provided, when registering and in this declaration of consent, are correct. The participant acknowledges that passing on their registration to third parties (for security reasons, the ski bindings have been specifically adjusted for the participant) is expressly prohibited.

The participant is liable to the organizer for any damages resulting from any such unauthorized disclosure.

When picking up various Stöckli ski models, the participant must identify themselves with a valid photo ID (driver's license or passport) and hand over the signed disclaimer of liability to the organizer. Furthermore, the participant confirms that they have provided the correct personal data for secure binding settings and that their data will therefore be stored in our system for their security. The participant agrees to comply with the rules on which the event is based and the instructions of the organizer. The organizer is entitled to make changes to and/or cancel to the event at any time (e.g. due to a bad weather conditions). Such changes do not give rise to any claims for damages from the participants. The participant hereby declares that they have the physical condition and skill level to take part in this event and is familiar with the dangers of a ski test.

**By signing, the participant declares, that they are taking part in the event at their own responsibility and risk.**

### DISCLAIMER

The participant declares, that in the event of damage, they have no claim against the organizer, the site owner or against other participants. The participant is aware of the dangers of skiing and takes part in the event with full knowledge of this danger. (ACT AT YOUR OWN RISK!).

The exclusion of liability applies to claims based on any legal basis, in particular to claims for damages arising from contractual as well as non-contractual liability and also to claims arising from unlawful acts. THE ORGANIZER SHALL NOT BE LIABLE FOR PERSONAL INJURY. It is expressly pointed out that there is no insurance coverage in the event of damage/theft to the material, unless in-house insurance was taken out in advance, when using the rental equipment.

**The organizer is not liable for health risks and dangers of the participants.**

The organizer has no obligation to pay damages to the participant if the organizer is obliged to make changes to the organization of the event or to cancel it due to force majeure or official orders, or for safety reasons. The participant must adhere to the ski operations and instructions, and piste rules provided and posted by Bergbahnen Sölden staff, and the guide in the ski area.

### CONSENT FORM

The participant hereby declares their consent that any photos and films taken by the participant in connection with their participation may be used, distributed and/or published as marketing materials for the companies involved, without any claims for compensation on their part.

### FINAL PROVISIONS

If individual provisions of the above general conditions of participation, the exclusion of liability or the declaration of consent are, or become ineffective, the remaining provisions remain unaffected. The organizer can justifiably prohibit the participant from participating if the participant cannot present a photo ID when picking up the test skis. With this signature, the participant accepts the conditions of the exclusion of liability and the declaration of consent. The participant has read the entire text carefully, understood it in full and confirms this with his or their signature.
